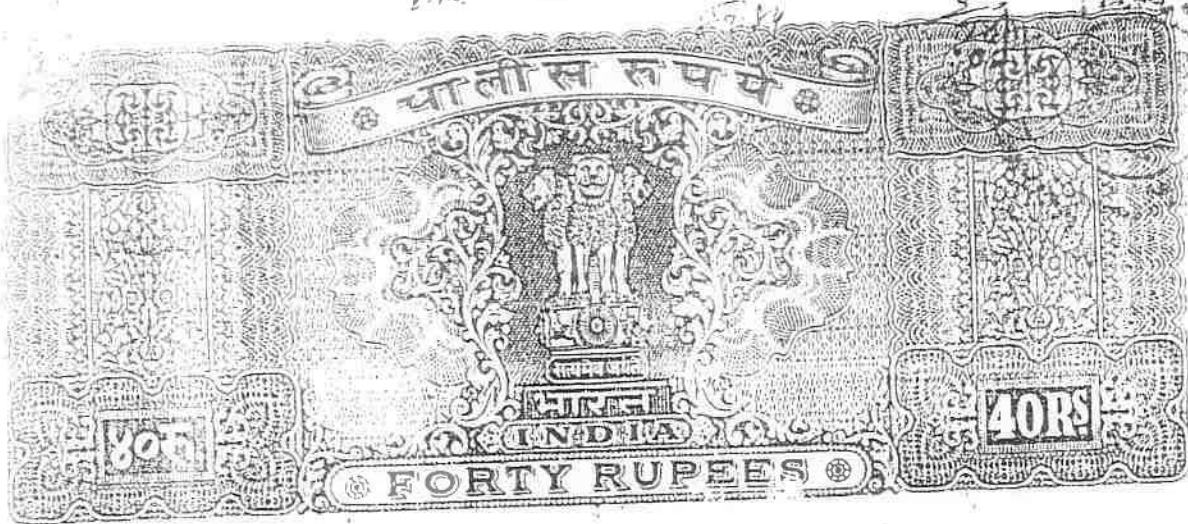

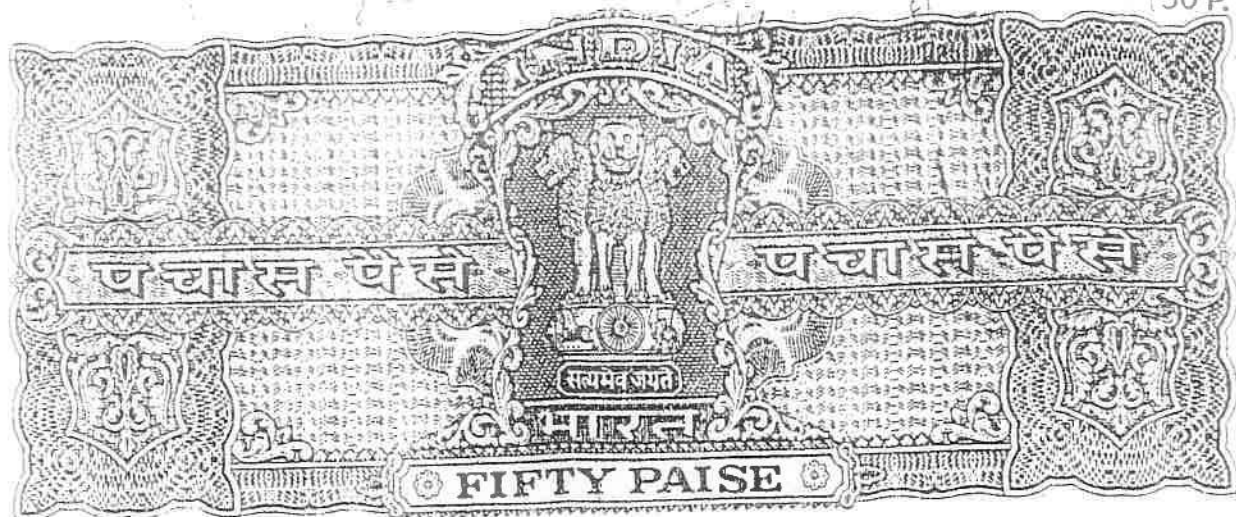

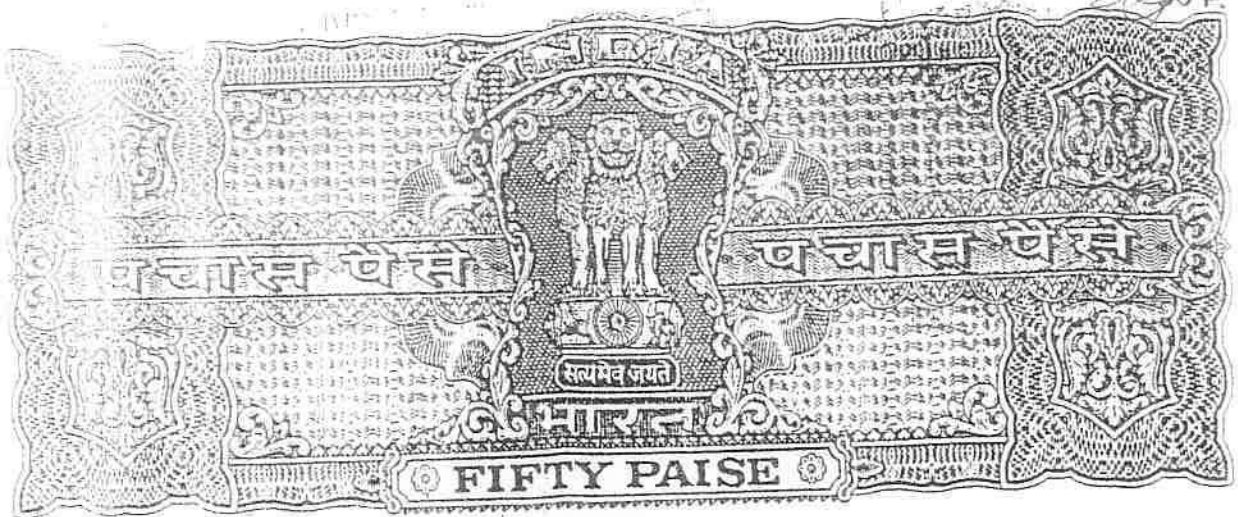

3. The management of the trust shall be vested in the Board of Trustees constituted by the Trustees mentioned hereinabove who shall be the first Board of Trustees.

(a) Regular and proper accounts of all the receipts and expenses of the trust shall be maintained and these shall be got audited by a qualified auditor once in a year. The accounting year of the trust shall be the Calendar year.
